

Coverage continuation when you leave



Life insurance continuation options can be confusing. Here's a brief overview of what's available to you.

Portability and conversion

Can I continue my coverage?

If you are no longer eligible for group life insurance as an active employee due to the voluntary or involuntary termination of employment (including retirement), you may be eligible to continue your in-force group insurance coverage without providing proof of good health.

Elections must be made within 31 days from your last day of coverage.

Take your coverage with you
